

EMP Storage Policies

Storage Policies

Storage charges are based upon the amount of time between the notification and the outgate after the allotted free time has expired.

- REZ-1 will collect storage for the NS, UP, KCS and CP.
- Storage free time begins at notification, and charges begin to accrue once the allotted free time has expired.
- Sundays & Holidays are exempt from free time (unless specified below).
- Storage charges will end once the unit has been outgated.

Storage Rates NS

In an effort to better service customers and increase efficiency at NS Intermodal facilities, effective April 16, 2018 the free time and storage provisions for domestic equipment grounding at destination will change as follows. **Note: The changes to storage free time will affect all NS shipments notifying on or after April 16th, while charges to charges will be in affect for all shipments that begin on or after April 16th:**

NS Storage Charges:

The following Intermodal facilities will be categorized as Tier 1. All domestic shipments grounding at Tier 1 facilities will receive a free-time allowance of Day of Notification plus one free day.

- Atlanta (Inman), GA
- Austell, GA
- Ayer, MA
- Calumet, IL
- Chicago 47th Street, IL
- Jacksonville, FL
- Kansas City, MO
- Morrisville, PA

All other Intermodal facilities will be categorized as Tier 2. All domestic shipments grounding at Tier 2 facilities will receive a free-time allowance of Day of Notification plus two free days.

NS Storage Charges:

Norfolk Southern is modifying the Domestic Storage program to incorporate a third level of escalation and account for both Strong and Soft market conditions. The Strong / Soft Market designation will be based on the market environment and capacity.

Effective **August 1, 2022**, Norfolk Southern will enter a Soft market. Advanced notification will be issued prior to the storage program entering a Strong market designation.
